ORDER AMENDING SHORT FORM COMPLAINT

THIS CAUSE having come before the Court on Plaintiffs' Motion for Leave to Amend the Short Form Complaint, and after review of the filing, and being otherwise fully advised in the premises, the Court **FINDS** as follows:


1. Plaintiffs' filed their Long Form Complaint in the *Exactech Master Case* docket on January 27, 2023.
2. Defendant David Petty is a named defendant in the Long Form Complaint.
3. The Court entered its Order Implementing Short Form Complaint on March 31, 2023, allowing plaintiffs to file a Short Form Complaint and select the various defendants and causes of action in the Long Form Complaint they wish to assert in their individual case.
4. The Order Implementing required that a Short Form Complaint be filed by April 24, 2023, for any plaintiff who wished to adopt the Long Form Complaint and whose case had already been consolidated in the *Exactech Master Case*.
5. Defendant David Petty was inadvertently omitted from the Short Form Complaint.
6. On April 25, 2023, Plaintiffs filed a Motion for Leave to Amend the Short Form Complaint to add Defendant David Petty to the Short Form Complaint and to allow Plaintiffs who have filed a Short Form Complaint to file the amended Short Form Complaint, adding Defendant David Petty.

Therefore, it is **ORDERED AND ADJUDGED** as follows:

1. The Short Form Complaint is amended to add Defendant David Petty at Paragraph 5. A copy of the amended Short Form Complaint is attached to this Order.
2. Any Plaintiff who filed a Short Form Complaint on, or prior to the date of this Order, may file the amended Short Form Complaint in their individual action within 10 days of the entry of this Order.


