### BELLWETHER TRIAL CASE MANAGEMENT ORDER NO. 3:

Pursuant to the court's April 19, 2024 Bellwether Trial Case Management Order No. 2 (Dkt. 590), the parties conferred and submitted the plaintiff David Caputo, 23-CV-1896 as a consensus choice for bellwether plaintiff from the National Pool. (*See* Dkt. 599.) The court selects Plaintiff David Caputo to be the plaintiff for Bellwether Trial No. 4.

The court previously set Bellwether Trial No. 1 for June 2025 and Bellwether Trial No. 2 for August 2025. (*See* Case Management Order for Bellwether Trials (Dkt. 521).) In light of the Parties' joint request to amend the discovery schedule for Bellwether Trial Nos. 3 and 4, (*see* Bellwether Discovery Letter (Dkt. 603)), the court sets the trial dates for the remaining bellwether trials and amends the Case Management Order for Bellwether Trials and the Bellwether Trial Case Management Order No. 2 as follows:
