## Stipulated Order Regarding the Discontinuance of Claims Against Greenstone LLC and Viatris Inc.

- This stipulated pretrial case management order sets forth processes and deadlines
  for discontinuing claims against Defendants Greenstone LLC ("Greenstone") and Viatris Inc.
  ("Viatris") (together, with Greenstone, the "Greenstone Defendants").
- 2. Plaintiffs' Liaison Counsel, on behalf of all Plaintiffs in this coordinated litigation, and counsel for the Greenstone Defendants have met and conferred and agree the Greenstone Defendants should be dismissed without prejudice from cases in this coordinated litigation through voluntary discontinuances. Plaintiffs' Liaison Counsel will also exert their best efforts to encourage other counsel with any case hereinafter filed in or coordinated with this litigation that names Greenstone or Viatris as a Defendant to promptly discontinue without prejudice claims against those Defendant(s).

3. Accordingly, the Court having been fully advised, ORDERS as follows:

a. Pursuant to N.Y. C.P.L.R. § 3217(b), all claims against Greenstone and Viatris are DISCONTINUED without prejudice from all cases naming Greenstone or Viatris as a Defendant that are currently pending in this coordinated litigation, as more specifically identified in Exhibit A to this Order. This Order shall be docketed by the Court on the coordinated docket and also on the individual docket of each case listed in Exhibit A. The discontinuance is effective 14 days after the entry of this Order on the Plaintiffs' individual dockets, unless an objection is raised by individual counsel before that time. See footnote 1, supra.

b. For any case naming Greenstone or Viatris as a Defendant that is subsequently filed in, transferred to, or coordinated or consolidated with this coordinated litigation after the date of this Order, or that currently is pending against Greenstone or Viatris in this coordinated litigation but is not identified in Exhibit A, upon service of the complaint, the Greenstone Defendants shall promptly file a notice of the issuance of this Order on the individual docket of such case. In providing such notice, the Greenstone Defendants will not be deemed to have waived—and, instead, have expressly preserved—all available objections and defenses, including, but not limited to, challenges to the propriety of service of process, the existence of personal jurisdiction, and the substantive viability of the Plaintiff's underlying claims. Pursuant to N.Y. C.P.L.R. § 2214(d), Plaintiff in such case will have 14 days from the date notice of this Order is docketed in the individual case to show cause why their claims against Greenstone or Viatris should not be discontinued without prejudice pursuant to N.Y. C.P.L.R. § 3217(b) and this Order. Greenstone

and Viatris will have 14 days from the date of filing of any show cause response to

file a reply to such response. If Plaintiff does not file a show cause response within

the 14 days provided by this Order, the Greenstone Defendants shall file a notice

of non-opposition with the Court and request that the Court issue an Order of

discontinuance without prejudice. Any Plaintiff in such a case is hereby put on

notice that failure to file a show cause response in accordance with this Order will

result in a discontinuance without prejudice of claims against Greenstone or Viatris.

Insofar as the Plaintiffs agree that the Greenstone Defendants should be dismissed

from this coordinated litigation because Pfizer was the actual manufacturer of the

product at issue, such that the Greenstone Defendants are no longer expected to be

active parties to these proceedings, counsel for the Greenstone Defendants shall not

be required to plead, appear for, and participate in matters in these coordinated

proceedings except as set forth in, and to ensure compliance with, this Order, absent

further direction of the Court.
