This order shall also apply to such cases, now pending or hereafter commenced, as may be coordinated into the combined litigation as a result of the September 8, 2025, Administrative Order or by any subsequent decision and order of this court.

#### ADMINISTRATIVE ORDER

By the authority vested in me as Administrative Judge of the Supreme Court, Civil Branch, New York County, and pursuant to the Order of the State of New York Litigation Coordinating Panel in the matter of Terry Fidler and Robert Fidler, Wife and Husband v. Pfizer, Inc., et al., LCP Index No.0001/2025, dated July 10, 2025, and the Rules of the Chief Judge (22 N.Y.C.R.R. § 53.1), it is hereby

ORDERED that all cases arising out of allegations that the use of the medication Depo-Provera (known generically as depot medroxyprogesterone acetate, or DMPA) caused or substantially contributed to plaintiffs' meningioma-related injuries, that are currently pending in any county of this State or that shall hereafter be commenced in any county of this State, shall be Coordinated in New York County and assigned to the Honorable Sabrina Kraus for the purpose of Coordination as set forth below and for all other purposes; and it is further

**ORDERED** that the Honorable Sabrina Kraus is designated as the Coordinating Justice for the Coordination directed by the Panel in the aforesaid Order; and it is further

**ORDERED** that (i) all pending actions listed in Exhibits A and B to the aforesaid Order and other pending cases arising out of allegations that the use of Depo-Provera (known generically as DMPA) caused or substantially contributed to plaintiffs' meningioma-related injuries that are not so listed but are pending in New York County or that, pursuant to the Order, shall be transferred to New York County for inclusion in the Coordination, and (ii) any such cases that shall be commenced hereafter in New York County, shall be assigned to Justice Kraus; and it is further

**ORDERED** that the attorneys hereafter filing any such matters in this court or effecting transfer of any such matters to this court pursuant to the said Order shall, as soon as practicable, file a Request for Judicial Intervention (which shall be without fee in any case in which a Request for Judicial Intervention was previously filed in a county other than New York County) and shall attach a copy of this Administrative Order to each such Request and shall designate the case as one related to the Terry Fidler and Robert Fidler etc., v. Pfizer, Inc., et al. matter.

It appears to the undersigned that the Coordination of and proceedings in the aforementioned pending cases and other such cases as may hereafter be filed shall be advanced and rendered more efficient for the parties, counsel, the Coordinating Justice, and the court if the
